Just for a heads up, there is going to be a National Day of Action protest on Saturday, 16 Nov 13, @ 1200 - 1500 hrs, in support of stopping the pipelines, reckless tar sands expansion and runaway climate change. The march is schedule to start 1215 Marginal Rd (Seaport Market) and travel on Lower Water St to 1726 Hollis St, Halifax, NS (Province House). If there are too many people in attendance, they will continue onto Grand Parade. They have scheduled Billy LEWIS - Mi'kmaq Elder and Amy SOCK, Eslipogtog member who claims she is a lawyer to speak to the group. Amy SOCK was present and vocal in the protest outside the Moncton Court House following the arrest of Eslipogtog War Chief John LEVI during the Rexton, NB protest.

- 6. (C//CEO) Synopsis: On 12 Sep 13, ten Mi'kmaq members attended CFB Gagetown to protest the fracking in northern New Brunswick and requested the military's assistance in with negotiating differences between the RCMP and Mi'kmaq protesters in northern New Brunswick.
- 7. **(C//CEO) Details**: On 12 Sep 13, CI Investigator A295 received an email advising of an incident which occurred at 1736 hrs, 12 Sep 13. The email stated nine natives, dressed in fatigues, barged into the Base Commanders office at 5 Div, CFB Gagetown to protest the fracking in northern New Brunswick and requesting the military's assistance, more specifically, the Military Police, with negotiating unknown matters.
- 8. (C//CEO): On 12 Sep 13, A295 contacted Source A, who confirmed 10 Natives from the Mi'kmaq Warrior Group, dressed in British combat uniforms attended the 3 MP Reg Det regarding an incident involving the RCMP two months prior. They demanded CAF to mediate between the Mi'kmaq protesters and the RCMP over the fracking in northern New Brunswick. Source A provided the following additional information:
  - a. 10 members of the Mi'kmaq Warrior Group attended the G3 HQ located at CFB Gagetown requesting to speak with Source C. CI COMMENT:

#### **COMMENT:**

- b. G3 HQ directed the group to 3 MP Regt without incident. Upon arrival to 3 MP Regt, two vehicles parked in front of the building and one vehicle parked on the north side of the building. The Mi'kmaq protesters exited their vehicles and gathered in the parking lot in front of the building without incident;
- c. Source B approached the Mi'kmaq protesters and requested the nature of their business, whereon they stated they were there to speak with Source C. They were advised Source C was not available; however, Source D would meet with their representatives. Among the 10 Mi'kmaq protesters, three protest representatives were self-identified as:

- d. Source B escorted the three Mi'kmaq protesters into a conference room where they met with Source D and the following was discussed:
  - (1) Southwest Energy is conducting Fracking in northern New Brunswick and their actions are destroying the environment;
  - there have been protests in the area of "Sikintu-k", NB where the RCMP are on the front line monitoring the situation;
  - (3) the Mi'kmaq protesters are claiming the RCMP are mishandling the situation by unlawfully arresting the Mi'kmaq protesters and using excessive force. In addition, they claim the RCMP are being contracted by Southwest Energy and demonstrating this by covering their vehicle license plates on their patrol vehicles, removing their name tags, wearing a cover vest labelled "Security" and failing to identify themselves when questioned by Mi'kmaq members;
  - (4) the Mi'kmaq protesters have retained a lawyer, Mr Brian SEAMAN, contact # 403-617-0082, who is reported to be legal counsel for their case. However, at this time, no official complaint has been made against the RCMP;
  - (5) the Mi'kmaq protesters stated according to "Treaty 752", they have the right to request the Military to negotiate or intervene and the right to protect their land using force if necessary; and
  - the Mi'kmaq protesters advised that if the situation were to escalate, they would supply more protesters than RCMP officers put on the front line. An example was given that if 300 RCMP officers were on the front line, they would still provide more protesters. They have organized a second line of protesters in the event the first line is arrested and claim they are willing to use weapons if necessary, but hope this tactic is not required. CI COMMENT:

Source D advised that contact with the official Mi'kmaq Warrior Group had been made and it was learned that the three individuals with whom they had spoken with, were identified as not being affiliated with the official organization. They in no way were authorized to speak for or provide representation on behalf of the Mi'kmaq Warrior Group. Further, they did not support the group's view of non-violence.

9. (C//CEO) On 13 Sep 13, A295 spoke with Source D who corroborated the aforementioned and further stated that there were no security concerns at the time and that all individuals left the base without inicident.

#### 11. **(C//CEO)**

Their website <a href="http://sacredfirenb.wordpress.com">http://sacredfirenb.wordpress.com</a>, has called on all friends, supporters, local residents and Maritimers to get involved. They claim they are committed to non-violent and peaceful means of reaching their goals. They are encouraging elected officials to change government policy, pursuing legal action, public education and civil disobedience. In addition, a news article from 1999 noted that and other supporters travelled to Newfoundland in 1999, in an attempt to exercise what they believed to be their treaty right to fish anywhere they choose. openly disregarded the official position of the Mi'kmaq Chiefs who were observing a no-fishing moratorium. The Mi'kmaq Chiefs openly stated they did not support the intrusion of other Mi'kmaq members in their area and do not support the use of violence.

12. **(C//CEO) CI COMMENT:** The group of individuals who attended the base and claimed to be representatives of the Mi'kmaq Warrior Group have been identified as not being affiliated with the official organization, frequently taking action that is in direct contravention of the groups official stance. The group that attended the base could be assessed as extremists within the Mi'kmaq community, who frequently operate outside the peaceful and official tenets of the Mi'kmaq Warrior Group for their own causes or benefit. Currently there is no indication that DND/CAF has any intent to intervene or mediate between the Mi'kmaq protesters and the RCMP. While the group departed base without incident, they did so feeling unsatisfied, indicating they may seek media attention, as they feel their treaty rights are not being respected. Further, it can not be ruled out that DND/CAF's unwillingness to intervene as requested may be deemed by the group as suitable grounds to take direct action against and protest DND/CAF. CFNCIU Det Halifax will continue to monitor the situation through Source partners and if further information is learned, it will be reported accordingly. **END CI COMMENT**

- 7. **(C// Details:** On 18 Oct 13, Sources A C reported the following:
  - Source A reported there had not been any incidents related the protest occurring on or near CFB Gagetown, Oromocto, NB or the Reserve Units located in Moncton, NB;
  - b. Source B related the current protest situation is a marked departure from the violence experienced on Thursday, 17 Oct 13. There are reports of sporadic peaceful protest occurring throughout NB and are expected to continue throughout the day. There has been no indication of extremist elements from outside the area attending and participating in the protests. There is no indication of an increase of individuals with weapons, which would indicate a potential for an escalation in violence; and
  - c. Source C reported sporadic peaceful protests occurring throughout NB and are expected to continue throughout the day Some traffic slow downs and stoppages are expected. The over all indications from the intelligence gathered, is that the situation is steadily deescalating; no further violence is anticipated at this time.
- 8. (C// ) CI COMMENT: This report is submitted for information and situational awareness only at this time. There currently is no identified direct threat to DND/CAF infrastructure or personnel in relation to these protests. However, given that protests in support of event of the 17th may sporadically and spontaneously develop with little to no warning, minor delays or detours for vehicle traffic transiting through effected areas should be anticipated and expected. There is no information to suggest that DND/CAF movements will be specifically targeted or adversely effected. A request for assistance, requesting logistical support in the form of modular tenting, generators and potentially for R&Q in the event of an escalation in protest activity is being anticipated. CFNCIU Det Atlantic will continue to monitor the situation through Source partners and if further information is learned, it will be subject to a further report. END CI COMMENT


