Goc meeting jan 17, 2013

Key departmental representation, cisis, rcmp, PS, cbsa, itac, tc.

The goal of the meeting is to create a deck for adm nsops, so they can get a better understanding of the situation from a whole of govt perspective.

Essentially admnsops wants comfort knowing that we have come together and can provide a high level overview of the situation.

The discussion started with a background on fn issues being brought forwards by inm, these include but limited to lack of consultation, broken treaties, resource sharing, legislative changes, nation to nation relationship, honour of the crown.

Inm movement not being led by an individual, but influenced by some key players. Much uncertainty, but movement has been consistent, generally.

Discussion of flash points ie, spence health, heavy police intervention, non aboriginal reaction, there are many unknown flash points now that social media is being used. Also govt announceables, ie mcs, budget, missing and murdered women etc.

Fn approach a balancing act, and so is police intervention, industry intervention, political intervention.

If inm makes it to spring, it could gain momentum with warmer weather.

Non aboriginal movements starting to move in, ie black block, anarchists etc... Influence is small but growing, unknown outcome.

Fn extremists mostly uninvolved, seen as grassroots only.

Pressure from industry on the rise politically.

Itac monitoring, but no reports, does not meet thresholds.
