**What's New**

- One protest was planned for today while a number of smaller activities may occur over the next week.

The Chief of the Elsipogtog First Nation, Aaron Sock, is to meet with the New Brunswick Premier, David Alward, later this week to discuss the dispute though a date and time have yet to be confirmed.

Premier Alward and his Energy Minister, Craig Leonard, have defended the provincial government's record in consulting First Nations communities on shale gas development. Both indicated that consultations have been extensive and more will occur if oil and gas reserves are discovered during exploration to ensure the environment is protected and that First Nations people benefit from development.

Bail hearings for the six protesters arrested last Thursday following a violent clash with the RCMP are moving slower than expected and may not be completed today.

The caravan that left from Vancouver for Rexton, New Brunswick earlier this week to support the protests appears to be far smaller than reported on Monday, which suggested that about 80 people could be involved.

### What's New

- The Green Party of New Brunswick has called for a public inquiry into the violence that occurred at last Thursday's protest.
- The New Brunswick Anti-shale Gas Alliance, an advisory body to a coalition of 28 community groups across the province opposed to shale gas, held a news conference this morning. It supported the call for a public inquiry and called for greater accountability of the RCMP. The Alliance also advised of its intent to raise \$100,000 to litigate the provincial government to halt shale gas development.

New Brunswick Premier, David Alward, stated to the media that he hopes SWN Resources, the company that is the focus of protests in Rexton, will resume operations. The Premier indicated that the development of an environmentally responsible shale gas industry in the province in consultation with First Nations could foster greater prosperity.

Bail hearings for three of the six male protesters held in custody since last Thursday were scheduled for today with the balance to occur on Wednesday. The six protesters face a total of 37 charges, which include mischief, threats and obstructing a police officer.

The number of First Nations protests continues to decline with none scheduled until Saturday according to the Idle No More website.

What's New

- The New Brunswick Assembly of First Nations' Chiefs issued a statement calling for the provincial government to suspend all shale gas exploration permits until a peaceful solution to the present dispute is negotiated.
- The Chief of the Elsipogtog First Nation, Aaron Sock, held a news conference and condemned the RCMP response to the protest last Thursday, which ended in violence and arrests. He also criticized the RCMP's aerial surveillance and stated that his community will continue to oppose shale gas exploration.
- Bail hearings for the six to eight protesters kept in custody over the weekend were deferred as defence counsel requested more time to review the charges. Three bail hearings will occur tomorrow with the remainder to be addressed on Wednesday.
- The court rejected the request from SWN Resources, the company attempting to conduct shale gas exploration near the Elsipogtog First Nation, to indefinitely extend an injunction barring protests from impeding its seismic testing. The injunction will expire today.
- No reasons were provided for rejecting the injunction extension but the judge will issue a written decision.
- Grand Chief of the Assembly of Manitoba Chiefs, Derek Nepinak, who is in New Brunswick to support the Elsipogtog First Nation, has called for a First Ministers Meeting on resource sharing. The Assembly of First Nations Ontario Regional Chief, Stan Beardy, indicated to the media that he will travel to Rexton, New Brunswick if the RCMP response escalates.

What's New

Five protesters in Rexton, New Brunswick, scene of the violent protest on Thursday, seized a Global TV vehicle and a CTV vehicle plus media equipment earlier this afternoon after threatening reporters. The reporters have now retrieved their vehicles and equipment and provided statements to the RCMP, which is investigating.

The Assembly of First Nations' Chiefs in New Brunswick issued a statement this afternoon condemning intimidation against the media and supporting a cooling off period. The Chiefs called for all blockades to end and for all protests to be peaceful.

Fracking demonstrations occurred today in Rexton, Sackville and Moncton without physical violence. About 100 people gathered near Rexton and blocked one lane of Highway 134 while others blocked Highway 11 in the same area. The RCMP were on site and both highways are now operating normally. Approximately 50 demonstrators in Sackville held anti-shale gas signs on both sides of the Main Street overpass while about 100 people gathered in Moncton.

The Grand Chief of the Assembly of Manitoba Chiefs (AMC), Derek Nepinak, is travelling to the Elsipogtog First Nation today to demonstrate the AMC's support for the protests. Grand Chief Nepinak issued a statement yesterday criticizing the RCMP for "unabashed violence and terrorism inflicted...against our indigenous Mi'kmaq and non-indigenous brothers and sisters who were peacefully assembled on their ancestral lands."

### What's New

- New Brunswick Premier, David Alward, and the Chief of Elsipogtog First Nation, Aaron Sock, met on Friday evening and agreed to a cooling off period in the shale gas dispute, which is reported to be a week. More talks are scheduled for early next week. Premier Alward indicated to the media that a moratorium on shale gas development is not under consideration.
  - Chief Sock issued a statement following the RCMP news conference on Friday, calling for calm and stating that weapons have no place in peaceful protests.
  - The number of protests in support of the Elsipogtog First Nation appears to be declining based on the Idle No More website. Upwards of 20 are planned for today, including protests at the Canadian consulates in San Francisco and New York, but less than five appear to be organized for Sunday at this time. [REDACTED]

What's New

- First Nations protesters set up barrier cones along the centre of the highway this morning into Rexton, New Brunswick where yesterday's violence occurred. Traffic was down to one lane but no police were on site.
- Sympathy protests occurred along the Trans-Canada Highway in Nova Scotia near Membertou and Waycobah and on the Canso Causeway. Traffic was halted on the Canso Causeway for a half hour but one lane was then opened with police directing traffic.

An anti-fracking protest was held in downtown Halifax with police on site and directing traffic.

- All of today's protests have been peaceful. Upwards of 50 protests in support of the Elsipogtog First Nation are planned for today and over the weekend according to the Idle No More website. A handful will occur in the US and include the Canadian consulates in New York and San Francisco.
- Eight of the 40 people arrested on Thursday in the violent protest in Rexton, New Brunswick have been charged with mischief, breach of an undertaking to keep the peace, unlawful confinement and obstruction. Another 31 have been released and assigned court dates. Some of the protesters arrested will remain in jail over the weekend out of concern that they will not respect the injunction if released. A bail hearing is scheduled for Monday morning.
- The RCMP held a news conference this afternoon and reported that firearms were seized at the protest encampment along with improvised explosive devices containing shrapnel, a large amount of ammunition, knives and bear spray (see attached photos). The RCMP also reported that shots were fired from within the encampment and Molotov-style explosives, rocks and bottles were thrown at officers, and that bear spray was used. Six RCMP vehicles were destroyed by fire.
- The RCMP indicated that death threats were made by protestors against members of a private security firm at the compound of the company attempting to undertake shale gas exploration. In addition, an arson attempt was made early this morning to the RCMP offices housed a building owned by Elsipogtog First Nation though only minor damage occurred.
- The RCMP indicated that its investigation is ongoing and additional charges are expected.
- Justice Minister Peter MacKay has called for an end to confrontations and resumption of talks to resolve the dispute over shale gas exploration.
- New Brunswick Premier David Alward is meeting with the Chief of the Elsipogtog First Nation and other First Nations leaders this afternoon.

**RCMP respond to serious threat to public safety; explosives, firearms and knives seized, Rexton, N.B.**

**Photo 1:** some of the explosive devices seized at the scene

**Photo 2:** firearms, knives, ammunition and bear spray seized at the scene

The RCMP seized a number of firearms from an encampment at a protest site set up along Highway 134 in Rexton on October 17, 2013. Police also discovered improvised explosive devices, a large amount of ammunition, knives and bear spray.

During yesterday's police operation, several shots were fired from someone within the encampment, Molotov-style explosives were thrown at police, six RCMP vehicles were destroyed by fire, and several improvised explosive devices were discovered and defused. These explosives contained shrapnel and had the potential to seriously injure or kill people. There were no reported serious injuries to either police or people gathered in the area. The previous day, on October 16, death threats were made by some of the protestors against members of a private security firm at the compound being blocked.

"The weapons and explosives we seized show that this was no longer a peaceful protest and there was a serious threat to public safety. We took the action necessary to address that threat," says New Brunswick RCMP Commanding Officer Assistant Commissioner Roger Brown. "Police officers demonstrated incredible professionalism as they worked to resolve the situation. Some in the crowd threw rocks and bottles at them and sprayed them with bear spray. Setting police cars on fire created a dangerous situation for everyone in the area, and it was at that point that police were forced to physically confront some in the crowd who refused to obey the law."

Forty people were arrested. Nine people are expected to appear in court on October 18 to face a variety of charges including pointing a firearm, mischief, assaulting a police officer, resisting arrest, obstruction of justice and failing to abide by a court injunction. Thirty other people were released on police undertakings and promises to appear in court at later dates. Our investigations continue and additional charges are expected.

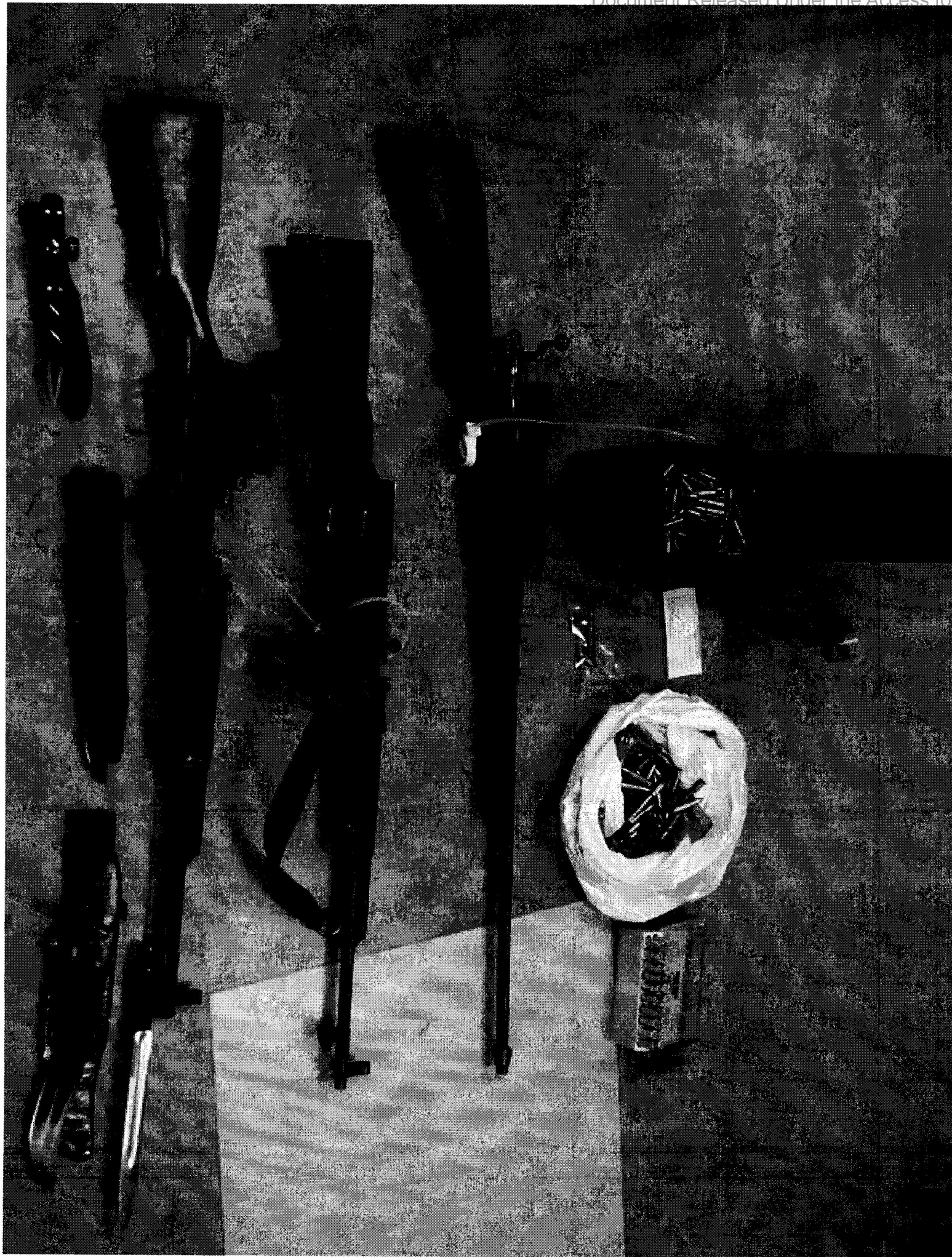
At approximately 2:30 a.m. on October 18, an attempt was made to burn the Elsipogtog First Nation RCMP office. Minor damage was sustained, and the Elsipogtog Fire Department was able to put out the fire. This is a building owned by Elsipogtog First Nation.

"The RCMP respects the rights and traditions of aboriginal communities and we know that the criminal behaviour of some individuals yesterday is not representative of the greater First Nations community," says A/Commr. Brown. "I met with the Elsipogtog Chief and Council last night and I was reassured to hear them say they don't condone violence and want peaceful discussions. We urge all those who want to demonstrate to do so peacefully and lawfully and allow things to calm down."

In Listuguj, supporters blocked the Listuguj bridge on the QC/NB border. In ON, a section of Highway 6 near Caledonia was closed on 17 Oct by supporters from Six Nations; open sources report that Highway 6 was reopened at around 19:30 EDT.

There were reports of small demonstrations of support in New York City and Washington, D.C. outside the Canadian missions. There are also reports of promises to gather and light sacred fires in major cities like Montreal, Ottawa, Winnipeg and Edmonton tonight.

The creators of Idle No More in Lethbridge, AB, said via Twitter that they wasted no time in getting a group together to march down the city's main drag Thursday afternoon.

**Description of incident:** According to media, at 07:45 EDT , on 17 Oct 2013, RCMP arrived at the route 134 blockade outside of Rexton, NB. The RCMP was on site to serve an injunction to protesters. The injunction, issued on 03 Oct, was granted to end the blockade of a SWN Resources company compound where exploration equipment is stored. The blockade was set up on 30 Sep. At approximately 09:45 EDT, RCMP reported that there was a brief standoff with some armed protestors, the issue was resolved peacefully and that the situation was calm and under control.

Media reported that violence later resumed at approximately 12:00 EDT. As of 14:15 EDT, the RCMP have arrested at least 40 people for various offences including firearms offences, uttering threats, intimidation, mischief, and for refusing to abide by a court injunction on Route 134, in Rexton, NB. At least one shot was fired by someone other than police, Molotov cocktails were thrown at police, and at least five RCMP vehicles were destroyed by fire. Further, the RCMP is also investigating suspected explosive devices at the scene.

Police remain at the scene to deal with a large gathering of protesters, and continue to monitor the situation.

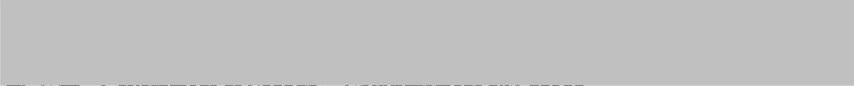

CALEDONIA, Ont. \_ Ontario Provincial Police say First Nations protesters have shut down Highway 6 in southern Ontario between the communities of Hagersville and Caledonia.

Const. Mark Foster says the the protest blockade involves 30 to 40 people.

A local news agency, Turtle Island News, says people from Six Nations shut down the road in solidarity with First Nations protesters arrested Thursday during a demonstration against shale gas exploration in eastern New Brunswick.

Foster says the protesters are walking on the highway and blocked motorists during the evening rush, but adds the protest has been peaceful.

Foster says a liaison team is talking with the protesters in an effort to get the road reopened.
